## IMPACT PLANS

Starlink Impact Plans, supported by the Government's ICT Services Division (ICTS), are designed for schools, clinics, and other public facilities.

They deliver fast, reliable Internet tailored for essential services. Unlike residential plans, which use individual billing, may have data caps, and don't support multiple users – Impact Plans are built specifically for the needs of public services.

## SAFETY

ICT Services supports public facilities in using Starlink's built-in safety tools, like malware protection, to keep networks secure and reliable.



ICT Services also works to ensure **government connectivity remains sustainable**. In remote areas, on-site help may not always be available, so reliable technical support and maintenance are essential parts of planning and budgeting.

In partnership with the providers, ICT Services is offering to approve **Starlink Impact Plans** for eligible public facilities including schools and clinics.

<sup>1</sup>: The Impact Plan provides a customer with 2TB of Priority Data each month. If customer's data use exceeds 2TB in a given month, the customer will not be rate limited until hitting 5TB of Priority Data use in that month. Monthly use in excess of 2TB of Priority Data should not be consistent or excessive.
